

## **Privacy Policy**

This Privacy Policy ("Policy") applies to [www.havenonthefarm.com](http://www.havenonthefarm.com), and Haven on the Farm Inc. ("Company") and governs data collection and usage. ### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:
